Power of Attorney instructions and verification

Verification:

To get things started, we will need the following:

- 1) If your company is a corporation, please send us any document received from the U.S. Department of Treasury, i.e. Internal Revenue Service (IRS) that reflects the proper EIN and company name.
- 2) We will also need a copy of the driver's license of the corporate officer who will be signing the Power of Attorney.
- 3) For individuals, please send us a copy of your social security card and driver's license.

Power of Attorney Instructions:

1. Check the appropriate box

2. **INDIVIDUALS and SOLE PROPRIETORSHIPS:** The full legal name of the individual as well as the full legal d/b/a name should be entered in this section

2. **CORPORATIONS and LIMITED LIABILITY COMPANY (LLC's):** The full legal name of corporation or LLC, as well as any d/b/a name

2. **PARTNERSHIPS AND LIMITED LIABILITY PARTNERSHIPS (LLP):** The full legal name of each individual partner including assumed business name of the partnership

If there is insufficient room, the names of all partners can be listed on a separate sheet of paper and attached to the Customs power of attorney form.

If the partnership is registered as limited liability partnership (LLP), enter names of the general partners who have authority to bind the firm.

7. **LIMITED LIABILITY COMPANY (LLC's):** Signature of the person granted authority to execute the power of attorney on behalf of the LLC

7. **PARTNERSHIPS AND LIMITED LIABILITY PARTNERSHIPS (LLP):** Signature of any general partner

8. Enter signatory's capacity (individual, owner, general partner, or corporate title)
